1. The Dance/Event begins at **7:00pm** and ends at **10:00pm**. No student will be admitted after 8:30pm and no student will be allowed to leave the dance before 10:00pm unless prior arrangements have been made with the Assistant Principal of Student Services and Supports.
2. **All students must present a STUDENT ID (ASB Card) at the registration table.**
3. CHS dress code will be strictly enforced. Students dressed inappropriately may be asked to leave.
4. Students who consume alcohol or any illegal substance before or during the Dance/Event will be removed, their parents will be called to escort the student home, and the student may be recommended for expulsion according to Board policy.
5. **Officers from Anaheim Police Department are scheduled to be present at the dance. Parents will be called if a student is suspected to be under the influence.**
6. Students may be checked for illegal or controlled substances. An outside "licensed and bonded" security company is contracted to conduct mandatory pat downs, purse checks, and event security. Students are encouraged to leave personal belongs at home. Canyon High School is not responsible for any lost or stolen items. The following items will be confiscated: Lanyards, cords, chains, liquids, gum, breathe mints and anything else security sees as posing a concern.
7. Trading or selling tickets is not allowed. Once a ticket has been purchased, there will be no refunds unless there is an emergency or valid medical reason.
8. Inappropriate conduct/dancing: i.e. freaking, twerking, etc., may be cause for removal from the Dance/Event and subject to possible further disciplinary action.

**Dancing Rules**

- Must stay upright
- No freaking, twerking, etc.
- Slow dancing is permitted.
- Hands must be kept at appropriate levels.
- No excessive body contact (making out, grinding on legs, etc.)
- Must wear shoes at all time
